



TITLE I SCHOOL-PARENT COMPACT

The Dennis B O'Brien School, and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help our children achieve the State's high standards.

School Responsibilities

 - C. Instruction by Special Area Teachers.
 - D. Objectives for lessons in all disciplines based on current curriculum and benchmarks aligned to Core Standards and so noted in Plans and Preparation.
 - E. On-going assessment of student progress and use of appropriate materials.
 - F. Use of mentor teachers and colleague partners to assist new teachers.

2. *Hold parent-teacher conferences (at least annually in elementary school) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:*
 - A. Fall – November 14,16 & 17th 2016
 - B. Spring – As needed.

3. *Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:*

4. *Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:*
 - A. Consultation with staff by parents will be held before and after school and during preparation periods at the school site. Parents may call for appointments via the school's main office leave voice mail or E-mail.

5. *Provide parents opportunities to volunteer and participate in their child's class and to observe activities.*

- B. Participate in District "Parent Volunteer Program"
- C. Invitations to special class activities, i.e. Thanksgiving Feasts, International Day activities, etc., plays and special class/school programs, i.e. Chorus, Band, Mini-Olympics.
- D. Parent visitations to class upon special arrangement.

Parent Responsibilities

- Monitoring amount of television and computer/video games their children watch.
- Volunteering in my child's classroom.
- Participating, as appropriate, in decisions relating to my children's education.
